1. What activities are you currently involved with or have been in the past related to ANA-Michigan or ANA?

I joined ANA and ANA-Michigan as soon as I graduated and am excited to be an active member, and recently applied to serve on a committee for ANA-MI. I am a participant in ANA's mentorship program as a mentee and my mentor has served as an invaluable resource. As a nursing student I was elected to a national position within the National Student Nurses' Association and attended five of their national conventions and conferences, where ANA always had a strong presence. I was able to meet Dr. Pamela Cipriano when she was a keynote speaker and heard incoming President Ernest Grant give an engaging presentation at another. I always left these gatherings motivated to advance my leadership abilities in a professional organization like ANA-Michigan.

I currently serve as a board member on my local Sigma Theta Tau International chapter, Kappa Epsilon, and Chair of Kent County's Breastfeeding Coalition. During this time I was also appointed to a year long term as a column reporter for Imprint, the professional magazine for student nurses published by NSNA. These positions facilitated my growth as an individual and team member. I enhanced my skills in conflict resolution, public speaking, working with a team that lived in multiple states throughout the United States, writing and abiding by an association's Bylaws and policies and procedures, and running a national election. I led my schools' association of over 400 members, increased our committee participation by over 100%, and led legislative campaigns. My goal was to ensure that our board members knew the needs of our members and our profession, and we worked tirelessly to make sure each student felt like a valued member of our association. I loved my time serving in these associations while in school and am ready to serve at the professional level.
